

"Slavery in America"

We Americans are all born "slaves" of the "UNITED STATES OF AMERICA, INC.". Whether we are red, yellow, black or white we are all "slaves" to this corrupt government. This is a fact of life and most Americans have come to accept the domination of us by government. The majority of the American people have become docile and allowed themselves to be violated, abused, terrorized and persecuted by government. The most basic principle of government is to protect our rights, privileges and immunities and when government fails in this task, it fails in its "Chief Design". We all understand our laws, all except BAR members who have sold their souls for the power and title of "Esquire". The BAR has established itself as the elite of our society by taking "Public Offices" in violation of our "Original 13th Amendment". The BAR has made itself our government, where all its membership agree they are above the law and are not required to justify their conduct. The BAR, like all gangs, use superior forces to defeat the individual. In court, the judge, prosecutor and defense attorney all work together to make you believe they can violate our rights and there is nothing you can do about it. Thus we have become "slaves" to the BAR members and their crimes that are acceptable to the BAR controlled government who operate these courts. If you disagree with this BAR policy, they bring in their enforcers, commonly referred to as "law enforcement". We have all seen this system in the past, labelled as "Organized Crime" with one distinct difference the Mafia protected the people, government protects its crimes and the

criminals (BAR members) within it.

"Elements of Slavery"

Government:

Government as we know it is supposed to be of the people, by the people, for the people. But we all know today's government is of the BAR, by the BAR, for the BAR. All other branches of government are established to serve BAR policy, like "law enforcement officers", serve the BAR and enforce its policy. Our police, sheriffs state police and federal marshalls can no longer be called upon to protect us against the criminals within government. Government no longer allows our law to determine criminal conduct, BAR policy determined by its membership, decides who is prosecuted and who is not. Thus government has made us slaves, the BAR our "Master", not citizens subject to the law and protected by law. Today we must argue our complaints to the perpetrators of the crimes.

Law:

Law is designed to serve and protect us from the criminals of our world who cause us injury or damage our property. This is the principle of law that has been abandoned in favor of BAR profits. Today our law has been corrupted

to allow BAR members to extort money from us for defense of fraudulent crimes, take our property without due process of law required by the 5th Amendment, or make us pay BAR members and corporations based upon fraudulent contracts. The law no longer serves the people, it is a tool of the BAR to keep us broke paying them. Consider the following:

Criminal law:

There are two types of crimes, these are "Tort Crimes" and "Commercial crimes". Once this is determined, the judge must determine the court's jurisdiction. To have jurisdiction the following challenges must be met.

"Tort Crimes" require an "injured party". The injured party must be a physical person that can be subject to cross examination. This establishes every case where the "STATE" is "Plaintiff" is "fraud". Therefore always demand the injured party be produced.

"Commercial crimes" require a "contract" that you knowingly signed and agreed to without reservation. Under UCC Regulations the "Original wet ink signed contract" must be present in court. If the attorney is unable to produce the original contract, he is engaged in "fraud", if a judge allows him to proceed you have "Conspiracy against rights" 18 USC 241. This is a "Constitutional Tort Crime".

Corporations:

A corporation is a dishonest man doing dishonest business under a fictitious name to avoid criminal prosecution for his crimes. Financial corporations such as mortgage companies, banks, credit card companies and loan companies all engage in "fraud" to defraud the people. Mortgage companies claim to loan you money to buy a house, they all act in fraud because your signature creates the money, they loan you nothing. They then charge you interest on money they didn't loan you to keep you paying them for life. If you have problems and can not pay their "extortion" payments, a bar member goes to court to seize your property, all equity you have established and obtain use of law enforcement to kick you out. Once you are out the mortgage company sells the house again for 100% of its value and the cycle begins again. This fraud is called foreclosure and this year an estimated 4 million BAR members will steal property from its rightful owner. Clearly this is "Organized Crime". Likewise Banks have no money of their own, only the depositors' money on deposit. The law is clear banks have but one purpose to secure the deposits, they can not loan them or risk them. Based upon this fact, the recent bail out of banks has defrauded tax payers of billions. I can not help but wonder how much was put in BAR members pockets to carry out this fraud upon the American People. This corruption was brought about by the BAR who has fraudulently created law that says a

corporation can contract. "Contract" is a right reserved to the people. A "Contract" requires two signatures and no corporation or its agent can lawfully sign a contract. Every BAR member in court, who tries to argue a "contract" is in court in "Fraud". This is every "Credit Card" suit. When a "Credit Card" corporation gives you a "\$5,000.00" line of credit and you sign the application, they process that "Note" through your "Straw man" account and receive the money. Then their fraud begins, first you are required to pay back all you receive, that is your money in the first place. Not only are you required to pay but pay at interest rates of an average of 18% to 25%. This "loan sharking" has been legalized by the BAR for their profit. If you do not pay their extortion payments, BAR members go to court and get a judgment against you that they use to garnish your wages or seize your bank account. Of course this is "Organized Crime".

Credit:

These acts of Mortgage companies, banks and corporations all operate on the "Organized Crime Operation" known as "Credit". "Credit" is these corporations telling us we must meet their demands to access our "straw man" accounts in the "Federal Reserve Banks". In fact, these corporations must have our social security number and signature to access our accounts. "Credit" is utilized to keep the people in poverty and allow corporations to unlawfully determine who can

and can not prosper. The way the system is supposed to work, is with your signature the debt is paid. BAR members have created the complexed fraud that allows corporations to deny us access to our accounts. The system of "Credit" is designed with but one purpose to make all the people "Slaves" to corporations, BAR members and Banks. When in fact they are supposed to serve our needs, protect our rights and aid us in prospering. With this knowledge we can defeat these criminals, all we have to do is refuse all contracts that are not paid by your signature.

TAXES:

The Constitution gives our government the authority to tax the people for two years during war time. This is the reason America has been at war constantly battling one evil or another ever since WWII. Prior to this law no American had to pay income tax, taxes were paid by corporations. Corporations have created the "fraud" that their employees must pay their taxes. Thus establishing rather than a corporation giving up some of their profits in taxes, the employees give up their pay to pay corporate taxes. Corporations get richer and the people suffer. The government barrows from foreign countries, claiming the American People are responsible to repay those loans. The President is but an agent and has no lawful authority to contract on behalf of the American People. In Fact, BAR members borrowed

the money, BAR members are the recipients of the funds and are responsible to repay those funds. Taxes are voluntary and I chose not to volunteer, because government does not serve and protect me. I sit in prison and not one government official informed of my illegal incarceration has come to my aid that is his lawful obligation. Today taxation without representation is the common practice of the BAR controlled government. There is no law that requires Americans to file a 1040A Form. Those who go to prison do so because they lie on a 1040A Form, which is the crime of perjury or tax evasion (lying about the amount made). I say let government pay the debts it created without our consent. I say let foreign countries handle the "BAR members" that fraudulently contracted on behalf of the American People, under international law.

Prisons:

Today in America the biggest rip off of tax payers is prisons. Americans are led to believe prisons are operated by government when in fact they are operated by corporations. Government has funded corporations to build and operate prisons that put Americans in slavery. The BAR has brought back the "Bonding of Slaves" by creating "GSA FS 24 BID BONDS" that are fraudulently circulated as securities. Of course trafficking in slaves is prohibited by the 13th Amendment, but BAR members change the name a little and continue to break our law.

Prisons are owned and operated by a "Board of Directors" made up of BAR members, judges, sheriffs, bankers and politicians who all get a share of the pie, that taxpayers pay. These corporations have established the common practice of utilizing "Forced labor" of prisoners to reduce their operational expenses to increase profits to their directors. Prisoners are denied medical and dental care to increase profits as well. The quality of food is obtrous and extortion is the common practice. Phone calls must be made through PCS Corporation who claims to only charge 10¢ per minute, but if you put money on your home phone or call collect the rate is doubled or trippled. Everything must be purchased from the prison store at a super inflated price, nothing is allowed to be sent to you. All prisoners are required to pay introvention fees set by the State before any money is allowed on your books. Of course any other Corporation can steal any money put on a prisoner's books without court order, such as Child Support Enforcement, unlawfully applying garnishment laws reserved to wages. My nine months in prison will net the Directors about \$64,000 of taxpayers money for housing me as a prisoner that costs about \$16,000 per year. I am just one out of an estimated 80,000 incarcerated in Missouri. Thus about 80,000 prisoners at a profit of \$48,000 per prisoner is alot of profit for the Directors of prisons at tax payers expense. BAR members create the propoganda we must be tough of crime, therefore taxpayers must pay for prisons. The truth is the majority of prisoners have

not injured anyone or damaged any property. Their crimes range from; 1) failure to pay child support (Violation Article I, Section 12 of the Constitution of Missouri) for imprisonment for debt; 2) DWI without injury or damage; 3) Probation Violations (Violation of Article I Section 31 for imprisonment for Administrative Codes) these include: failure to find a job, not reporting a move within 24 hours over a week end, smoking marijuana or having a beer, or in my case filing a document in court. These are the common reasons why people are enslaved in prison. The BAR utilizes these minor infractions to increase profits of Corporations who operate prisons and taxpayers must pay for this corrupt system. With the current state of our economy, Governor Nixon will cut the budget of schools but won't cut the budget of any prison. BAR members profit from prisons, they don't make anything off education. The illusion of tough on crime is government profiting BAR members, in truth murder gets less time than marijuana sales. Prison is nothing but "Conspiracy to defraud taxpayers", and keep the American People in Slavery to the BAR.

Summation

As I have said many times, the BAR is destroying our Nation from within. They have created this system of corruption whereby they profit at the expense of the people. They have coined it "Democracy" whereby the few (government) dictate law to the majority (the American people). Unless we re-establish

lawful government, one free of BAR influences, free of lobbyists of corporate interest and free of unconstitutional methods, we are destined to lose all our liberties. America was once the greatest nation ever conceived, but we have allowed ourselves to be ruled by a tyrannical organization (BAR) just like all other empires of past generations. Government has fraudulently labelled me a criminal, for exercising my 1st Amendment right of freedom of speech. Regardless of their efforts, I am an American who wants to preserve our nation and Constitution for future Americans. I say all BAR members are anti American and as long as the BAR exists in our Nation, they will be a threat to our Nation. Not one, all of them. There are far more Americans than BAR members and many believe violence is the answer. I say voting them out of office, charging them with their crimes and putting them in prison and refusing to hire them is far worst punishment for these greedy people. I say all Americans should stop supporting the "British Government" in power and act independently and collectively to restore an American government to power. All Americans must join in truth or our great nation will die. I say long live America.
