

The corruption of America

Today we face an ever growing government, that is well established as a "dictator" of our laws, morals, ethics and principles, that the majority of Americans disagree with. Government tells us we can not smoke marijuana, that has been proven to be a preventative to many illnesses and treatment for others, so we will go to state sanctioned doctors for medication. It doesn't matter that their pills don't work, doctors make money for prescribing them, pharmaceutical companies make billions creating them and government gets paid to approve them. The patient is lost in the greed of these so called professionals who operate an immoral system of profit at the expense of those they have sworn to treat. Now we are told we must pass national health care, to allow insurance companies to raise their rates and make it a crime to not meet these corporate demands. Just another example of corporate interest prevailing over the needs of the people.

For almost 20 years I have worked and invested all I had to establish accountability amongst BAR members. But I am not allowed to succeed. The Constitutions have been over thrown by those loyal to the British who have united our Public Offices to act against the principles our nation was founded upon. BAR members regulate BAR members, Bankers regulate Bankers, no one regulates government and if we speak out

against corruption we are sent to prison and all law is ignored. This is the British ruled America of today. My felony crime is exercising a right to "freedom of speech" that opposed "BAR Policy". This alone establishes their authority to throw me in prison and ignore "Habeas Corpus" a mandated federal law of Article I, Section 9 of our Constitution. BAR Policy says if you oppose the BAR you are a criminal and denied all due process of law. This website has shown you all the facts, law and evidence of my case, the question is "Why isn't the law upheld by those responsible to be impartial and treat each of us fairly?" The answer is simple "BAR Policy" says ignore all law, ignore all facts, ignore all evidence and support the corruption that Denny Ray Hardin opposes. This "common practice" is present in every Public Office of America. The President has been informed, the United States Attorney General, all courts state and federal, have all opposed the Constitution and our laws in favor of "BAR Policy". Of course "disloyalty" to the Constitution is a crime under 18 USC 1818. "BAR Policy" is simple to understand, support the corruption of the BAR or you are a criminal.

Today in America, the BAR (Judges, attorneys, bankers corporations and politicians) have united against the American People. BAR members can steal our houses, cars, bank accounts and savings without due process of law. They do this under

threat of deadly force, by armed law enforcement officers who act as "enforcers" of "BAR Policy". Their "Oath of Office" have been thrown out the window in favor of job security. All must support and enforce "BAR Policy" or lose their job. Most quit when they see how corrupt the BAR is, those who remain have sold their souls for a pay check. Their conduct is criminal, because if a private citizen did any of these acts, they would be prosecuted and imprisoned. In my case, there is no possibility W. Stephen Nixon, the Governor's brother, would not act in prejudice and railroad Denny Ray Hardin to prison. The criminal complaints filed against him can not be right because he is a judge. W. Stephen Nixon is perfect and would never let his power go to his head and stop someone who was acting within the law. This is not possible, or atleast that is what all other courts says by refusing to examine the case.

It comes down to a question of accountability, when a judge can commit crimes in a Public Office and all others

allow those crimes to prevail. This "Conspiracy against rights" is the "common practice" of all courts in America today. We must just accept that "BAR Policy" is now the "Supreme law of the land" and has replaced our Constitution. Based upon my experience the following is the "BAR Policy" of America.

1. All BAR members are perfect and never make a mistake.
2. Appeal courts are enforcers of BAR Policy and judges are always right.
3. No BAR member can be challenged or prosecuted for any crime.
4. We must accept BAR Policy without authority of law.
5. We must pay whatever fee a BAR member demands.
6. We must freely give our property to all BAR members.
7. We must never challenge a BAR members criminal conduct.

9. We must accept BAR members interpretations of law.
10. We must accept we have no rights, no privileges and no immunities.
11. all BAR members are superior to the Constitution.

13. The American People are slaves to the BAR.

These clearly describe the current judicial system of America. If we will just follow these simple rules of our society we will not get in any trouble. I refused these rules and have been made a prisoner of the BAR. For the statement "I will abolish the court", I served three years of probation, 9 months

in prison and 4 years 3 months of parole to come. Do you believe this is fair punishment for exercising a Constitutional right? 8 years of my life. Do you believe this is cruel and unusual punishment? Do you believe the punishment fits the crime? It doesn't matter what you think, it only matters what the BAR thinks. All BAR members agree since the Governor's brother said it, it must be just and there is no reason for review. Based upon this I suggest no one should ever file an appeal, that is just another method of stealing our money, they never rule against a corrupt BAR member. If we just accept BAR Policy outlined above there is no need for appellate courts, they should be abolished. Appellate courts are utilized by BAR members to keep us fighting and paying them more, through fraud claiming we can win on appeal. Years later and thousands of dollars later, the BAR member is sorry you didn't prevail but that's it. You are broke and can't oppose their injustice anymore. This is BAR Policy in its most basic form, take liberty, take their money, wear them down by denying justice and BAR Policy always prevails.

There has been a decline in the morals, ethics and principles of our nation. BAR members are the most dishonorable because they can lie to your face, take your money and railroad you to prison. Amongst BAR members the more willing you are to persecute, abuse, terrorize and defraud the American people, the higher you go in government. But this is not

their fault, their greed and desire for power drives them, I blame the American People for electing them, supporting their campaigns and promoting their election. I have tried everything I can think of to restore our Constitutions and justice in the courts, I have come to the end of my efforts. I have tried to appeal to the honorable men in the courts, only to find dishonorable judges. I have tried to appeal to the courts based upon the principles of the Constitutions in every court of this land and not once have they been upheld by any dishonorable judge all have acted within BAR Policy. My crime is believing in the Constitution, our law and the integrity of this nation. I have learned it is a "dog eat dog" world and those who help others always lose.
